IRS STIMULUS REBATE

Do you qualify for the IRS Stimulus Rebate this year? Do you expect to see the check some time in May? If you don't file a tax return you will **not** get a check. Even if you owe no tax and have not filed a return for several years, you **MUST** file a return to be eligible for the Stimulus Rebate.

But the filing process is very simple if you owe no taxes. There are just a few lines that need to be completed on a single form. If you have any questions, need a form to fill in, or want help completing the form, you can contact Jim Rudolph. Jim has copies of the required form and can assist in filling in the blanks. Remember, if you do not file a tax return in 2008 you will not get a Stimulus Rebate check.
