RECYCLING ALUMINUM CANS, PAPER AND CARDBOARD

There is a large dumpster in the compound for Laurel Estates. Every newspaper, can, or cardboard box can add up to quite a bit of cash earned for US. So let's remember to collect these items and place them in the Laurel Estates container in the compound.

Please flatten cardboard boxes before placing them in the bin. No bags in the can bin, please!

Items placed in these bins become property of the Lot Owners Association. Unauthorized removal is considered theft. The Sheriff should be notified when such activity is observed!!

THE TRASH COMPACTOR

Ultra V asked us to remind everyone to NOT climb inside the unit. It is dangerous and could result in great harm or death if you are caught inside once compacting has begun.

The company that services the compactor has complained that large items (which cause damage to the unit) have been placed inside the compactor – i.e. toilets, love seats, dressers, chairs, paint cans. This is only for trash, not large item disposal. If unauthorized items continue to be placed in or around the compactor, it could be taken away entirely.

If you do not want to pay Newell (239-691-2575) to remove unauthorized items, you may deliver them to the dump at 6441 Topaz Ct. in Fort Myers.

Other measures may be taken by management if the unauthorized use of the compactor continues.
